

The Lodzia Textile Company Limited.

1. The name of the Company is “The Lodzia Textile Company Limited”.
2. The registered office of the Company will be situated in Palestine.
3. The objects for which the Company is established are:-
 - (1) To carry on all or any of the businesses following: namely, cotton spinners and doublers, flax, hemp, and jute spinners, linen manufacturers, flax, hemp, jute, and wool merchants, wool combers, worsted spinners, woolen spinners, yarn merchants, worsted stuff manufacturers bleachers and dyers, and makers of vitriol, bleaching, and dyeing materials, and to purchase, comb, prepare, spin, dye, and deal in flax, hemp, jute, wool, cotton, silk, and other fibrous substances, and to weave or otherwise, manufacture, buy and sell and deal in linen, cloth, and other goods and fabrics, whether textile, filted, , netted, or looped, and to supply power.
 - (2) To carry on all or any of the business of silk mercers, silk weavers, cotton spinners, cloth manufacturers, haberdashers, hosiers, manufacturers, importers, and wholesale and retail dealers of and in textile fabrics of all kinds, milliners, dressmakers, tailors, hatters, clothiers, glovers, lace manufactures and wholesale and retail dealers of and in household fittings ornaments, stationery, buttons and fancy goods, and generally of and in all manufactured goods, materials, provisions, and produce.
 - (3) To purchase , take or lease or in exchange, hire or otherwise acquire and hold any estate or interest, rent, sell, let on lease, or otherwise dispose of any lands or to erect thereon offices, shops, showrooms, factories, workshops, sheds, storehouses, dwelling houses, or other buildings and to acquire, fix, and install therein, and furnish the site with any machinery, plant, fixtures, furniture, utensils, and tools required for the purpose of carrying on any of the business of the Company.
 - (4) To apply for purchase otherwise acquire any patents, improvements, trade marks, trade names, copyrights, concessions, or the like, conferring an exclusive or non exclusive right to use, or any secret or other information of whatever kind which may seem capable of being used for any of the purposes of the Company.
 - (5) To acquire and undertake the whole or any part of the business, goodwill, and assets of any person, firm or Company carrying on or proposing to carry on any of the businesses which this Company is authorized to carry on or possessed of land, houses, kilns, buildings, machinery, commodities, goods, or property of any kind suitable for the purposes of this Company, and, as any part of the consideration for such acquisition, to undertake all or any of the liabilities of such person, firm or Company, or to acquire an interest in, amalgamate with, or enter into any arrangements for sharing profits, or for cooperation, or for limiting competition, or for mutual assistance with any such person, firm or company, and to give or accept among other forms of consideration, by way of consideration for any of the acts or things aforesaid, or property acquired, any shares, debentures, debenture stock or securities that may be agreed upon, and to hold or retain, or sell, mortgage and deal with any shares, debentures, or securities so received.

- (6) To enter into any arrangements with any Governments or authorities Supreme, municipal, local or otherwise, that may seem conducive to the Company's objects, or any of them, and to obtain from any such Government or Authority any rights privileges and concessions which the company may think it desirable to obtain and to carry out exercise and comply with any such arrangements, rights, privileges and concessions.
- (7) To promote any Company or Companies for the purpose of acquiring all or any of the property, rights and liabilities of this Company or for any other purpose which may seem directly or indirectly calculated to benefit this Company.
- (8) To purchase rent, hire or otherwise acquire, sell, let and dispose of buildings, easements, rights, privileges, concessions, machinery, patents, plant, stock in trade and real or personal property of all kinds necessary or convenient for the Company's business.
- (9) To establish and support or and in the establishment and support of associations, institutions, funds, trusts , and conveniences calculated to benefit employees or ex-employees of the Company or its predecessors in business, or the dependants or connections of such persons, and to grant pensions and all allowances, and to make payments towards insurance, and to subscribe or guarantee money for charitable or benevolent objects, or for any exhibition, or for any public general or useful object.
- (10) To sell improve, manage, develop, exchange, lease, mortgage, dispose of, turn to account, or otherwise deal with, all or any part of the property and rights of the Company.
- (11) To carry on the business of mechanical engineers and manufacturers of machinery, tool makers, builders, metallurgists, electrical engineers, carriers and merchants.
- (12) To borrow or raise or secure the payment of money in such other manner as the Company shall think fit, and in particular by the issue of debentures or debenture stock, perpetual or otherwise, charged upon all of the Company's property (both present and future) including its uncalled capital, and to purchase, redeem and pay off any such securities.
- (13) To lend money to such persons and on such terms, as any seem expedient, and in particular to customers and others having dealings with the Company, and guarantee performance of contracts by any such persons.
- (14) To draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange, bills of lading, warrant debentures and other negotiable or transferable instruments.
- (15) To transact and carry on all kinds of agency business.
- (16) To sell or otherwise dispose of the whole or any part of the undertaking of the Company, either together or in portions, for such consideration as the Company may think fit, and in particular for cash or shares, either fully or partly paid up, debentures or securities of any Company purchasing the same.

- (17) To carry on any other businesses, whether manufacturing or otherwise, which may seem to the Company capable of being conveniently carried and in connection with the above mentioned business or objects, or calculated directly or indirectly to enhance the value of or render profitable any of the Company's property or rights.
- (18) To do all or any of the above things in any part of the world and either as principals, agents, contractors, trustees or otherwise and either by or through agents, trustees, contractors or otherwise and either alone or in conjunction with others.

And, it is hereby declared that the Company is established within view that the official rest days of the enterprise, plants, crafts, offices and other works of the Company shall for all times of the existence of the Company invariably remain Saturdays and Jewish Holidays.

4. The liabilities of the members is limited.
5. The share capital of the company is - . 12000 divided into 1200 shares of - . 10 each.
